In the future, the European Economic Area will require even broader and more particular competences. The EBBD portfolio has been specifically designed with these competences in mind; the EBBD supports the European economy by educating a top qualified workforce.

Graduates receive an additional, internationally renowned certificate, which also serves as preparation for academic studies with a European focus.
